LIST OF TYPE CODES FOR E-FILING DOCUMENTS

(NOTE: AN "A" IN FRONT OF TYPE CODES REPRESENTS THAT THE DOCUMENT IS TO BE FILED IN ALEXANDRIA RECORDS & AN "N" IN FRONT OF TYPE CODES REPRESENTS THAT THE DOCUMENT IS TO BE FILED IN NEWPORT RECORDS)

Alexandria or Newport: As a general rule Documents whose Group Numbers start with "1, 2, 3 & 4" – Get recorded in Newport Records & Documents whose Group Numbers start with "5, 6 & 7" – Get recorded in Alexandria Records.

***Some type codes only get recorded in Newport Records, therefore the A-codes for those type of documents are not an option on this list*.**

If your document(s) contain more than 1 Parcel Identification Number, you must continue to submit for recording via mail or in person as the e-filing system is not yet set up for collection the additional \$4 fee for additional parcel after the first one.

HELPFUL INFORMATION FOR COMMONLY RECORDED DOCUMENTS:

TYPE CODE

DEED	=	IF A DEED IS EXEMPT FROM TRANSFER TAX THE DEED MUST STATE THAT IT IS EXEMPT AND PROVIDE THE COMPLETE APPLICABLE KRS STATUTE THAT APPLIES FOR SAID EXEMPTION WITHIN THE DOCUMENT. BE SURE TO INPUT "0.00" IN SALE PRICE AS WELL AS "0.00" IN TRANSFER TAX WHEN ENTERING IN E-FILE SYSTEM IF IT IS EXEMPT FROM TRANSFER TAX. (NOTE: The Fair Cash Value is still required to be on a deed that is exempt from transfer tax in most cases.)
MTG	=	MORTGAGE WITHOUT A MERS ASSIGNMENT WITHIN
MTGWA	=	MORTGAGE WITH A MERS ASSIGNMENT WITHIN
MEMO	=	IN ADDITION TO OTHER TYPES OF MEMORANDUMS, CAMPBELL COUNTY RECORDS "MEMORANDUMS OF TRUST" AKA "CERTIFICATES OF TRUST" UNDER THIS CODE. THE TRUST CODE IS FOR RECORDING THE ENTIRE TRUST DOCUMENT.
