## REGISTRATION

All third party purchasers wishing to participate in the Campbell County tax sale must complete a registration form (attached) and submit it along with all required fees and deposits to the county clerk's office @ 1098 Monmouth Street, Suite 204, Newport, Kentucky 41071 by 4:00 pm on August 3, 2026 (NO EXCEPTIONS). The following items must be submitted to the county clerk's office on or before the above date:

- The registration form that contains the name and contact information for the third party purchaser;
- A copy of the registration certificate issued by the Department of Revenue (if applicable);
- The list of priority certificates of delinquency the purchaser intends to acquire (if any);
- The list of current year certificates of delinquency the purchaser intends to acquire (if any);
- The applicable registration fees; and all applicable deposits:  
PRIORITIES REQUIRE 100% DEPOSIT OF TOTAL (BE SURE TO OBTAIN THE AUGUST FIGURES), PLUS A \$30 RECORDING FEE PER PRIORITY CERTIFICATE &  
CURRENT YEAR TAX BILLS REQUIRE 25% DEPOSIT OF TOTAL.  
**NOTE: BLANK CHECKS ARE NO LONGER ACCEPTED!;**
- Lien Issues Agreement (must be signed and dated); and

## REGISTRATION FEES

A registration fee of \$5.00 dollars for each bill for the priority list and \$10.00 for each bill for the current list (not to exceed \$250.00 dollars) is due at the time the lists are submitted.

The County Clerk will not and is under no obligation to issue a refund of registration fees.

**CAMPBELL COUNTY**  
**2025 DELINQUENT TAX SALE**  
**PAYMENT REQUIREMENTS**

On August 12, 2026 the Campbell County Clerk will hold the 2025 certificate of delinquency tax bill sale at 1098 Monmouth Street, Room 204, Newport, Kentucky 41071 @ 9:00 a.m. This year the sale will NOT be an in-person sale and will be performed electronically Lottery style.

According to KRS 134.010 (Sec.8-1b), the clerk shall set terms for payment of purchased bills.

The only forms of payment accepted by the clerk for the initial deposits are: CASH, CASHIER'S CHECK, OR CERTIFIED FUNDS.

The Deposit(s) received prior to the tax sale will be applied toward the total(s) due for each Third Party Purchaser. Any additional amounts due over and above the initial deposit(s) received must be paid by next business day or a blank check may be delivered to the clerk the day of the tax sale to be completed for the additional amount due for convenience purposes.

Any applicable refund checks will be issued within 10 working days after the sale if necessary.

**SALE PROCEDURES**

The drawing of order will be held on Friday, August 7, 2026 at the Campbell County Clerk's Office-Real Estate Department Records Room. You do NOT have to attend in person, unless you choose to. The list of the drawing order will be posted on our website following the drawing.

The sale will begin at 9:00 a.m. August 12, 2026.

Bills will be sold individually. (NOT IN LOTS).

## PRIORITY CERTIFICATES OF DELINQUENCY

This list of priority certificates of delinquency is to be clearly marked as such and it needs to include the following information:

- The current year's tax bill number;
- The name on the tax bill;
- The prior year certificate of delinquency's bill number, tax year and book and page number where the prior year certificate of delinquency is filed;
- The parcel identification number and a copy of the prior year certificate of delinquency; and
- Amount due/100% OF TOTAL, PLUS A \$30 RECORDING FEE PER PRIORITY CERTIFICATE (CASH, CASHIER'S CHECK, OR CERTIFIED FUNDS). \*BE SURE TO OBTAIN AUGUST FIGURES\*

## CURRENT YEAR CERTIFICATES OF DELINQUENCY

This list of current year certificates of delinquency to include the following information and be in **PRIORITY ORDER** so that we can determine which available bills will be assigned to each Third-Party. (e.g. Entity number 1 will be assigned the first bill on their list, entity number 2 will be assigned the first bill on their list if it was not the first bill on entity number 1's priority list and so on). The purchases will continue until there are no more available bills on your list.

- The bill number;
- The taxpayer name;
- The parcel identification number; and
- Amount due/25% OF TOTAL (CASH, CASHIER'S CHECK, OR CERTIFIED FUNDS).

6. County account/parcel number (if applicable); and
7. A copy of the prior year certificate of delinquency.

7. Please submit a separate list of the current year certificates of delinquency--for which no prior year claim exists--you would like to purchase at the tax sale. For each certificate of delinquency the following information needs to be provided: \*\*\*MUST BE IN PRIORITY ORDER\*\*\*

1. Tax bill number;
2. Taxpayer name;
3. Amount due on the certificate of delinquency;
4. The total due for all certificates of delinquency.

## LIEN ISSUES

**THE CAMPBELL COUNTY CLERK'S OFFICE CANNOT BE HELD RESPONSIBLE FOR PROBLEMS RELATING TO ANY CERTIFICATES OF DELINQUENCIES PURCHASED BY A THIRD PARTY THAT HAS NOT BEEN PROPERLY RESEARCHED.**

Tax bills purchased in this office may be and are subject to prior liens, current foreclosures, bankruptcy proceedings, or tax bills not properly exonerated.

This office often is not informed in a timely manner of bankruptcy litigations in which the county attorney or department has filed a claim.

Third party purchasers are not allowed to buy certificates of delinquencies that are in bankruptcy.

Third party purchasers are encouraged to do their own research **before** purchasing certificates of delinquency at the tax sale. A subscription service known as **"PACER"** can be utilized by third party purchasers to get up to date information about **bankruptcy filings**.
